

Building Safety Bill

- Reforms legislation relating to building safety
- Establishment of Building Safety Regulator
- Power for local authorities and fire and rescue authorities to assist Regulator
- Power for Regulator to issue directions to local authorities and fire and rescue authorities
- Duty for Regulator and local authorities and fire and rescue authorities to co-operate with each other

Building Safety Bill

- Dutyholder regime for higher-risk buildings
- Extension of limitation period for claims relating to defective premises
- Duty to ensure that work does not render dwelling unfit for habitation
- Register of building inspectors



Case Law – Business Rates

- Avoidance Schemes Court looking closely at validity of arrangements
 - Hurstwood Properties Ltd and Others v Rossendale Borough Council and another [2021] UKSC 16
 - Isle Investments Ltd v Leeds City Council [2021] EWHC 345 (Admin)
- Rate relief for charities
 - Nuffield Health v Merton London Borough Council [2021] EWCA Civ 826
 - Question is whether charity is using premises for its charitable purposes

Borrowing from the Public Works Loan Board

- Local authority must not borrow more than or in advance of need purely in order to profit from investment of extra sums borrowed – Debt for yield
- New guidance published by HM Treasury in August 2021
- PWLB will lend to refinance debt even if project would not now be eligible for PWLB loan
- New Circular 163 Lending Arrangements For PWLB Loans

Property Case Law Update

- Poundland Ltd v Toplain Ltd. Unreported County Court Pandemic Clause in lease
- <u>Capitol Park Leeds plc v Global Radio Services Ltd [2021] EWCA Civ 995 (5 July</u> <u>2021)</u> Satisfaction of Break condition
- In Rittson-Thomas and others v Oxfordshire County Council [2021] UKSC 13 Schools Sites reverter not triggered
- Monsolar IQ Ltd v Woden Park Ltd [2021] EWCA Civ 961 Rectification of rent review formula
- The Royal Parks Ltd and another v Bluebird Boats Ltd [2021] EWHC 2278 (TCC) Annexation of fixtures
