

"Socially Responsible Procurement Duty"

- End-to-end, overarching duty on organisations
- .. in designing, drafting, negotiating, awarding and managing a contract..
- to seek to improve economic, social, environment and cultural well-being, by
- Setting and publishing objectives for all procurement




Optimeiddio – yn flaenorol Optimisation - previously

Ar gyfer contractau adeiladu mawr (1) a gwasanaethau allanoli (2) uwchben:

- 1. Cymalau gwaith cyhoeddus cymdeithasol
- 2. Cymalau gweithlu cyhoeddus cymdeithasol

Tri cam sydd eu hangen:

- 1. Cynnwys mewn contractau
- 2. Cynnwys trwy cadwyni cyflenwi
- Rhoi proses ar waith i sicrhau bod y rhain yn cael eu gweithredu

Rhoi gwybod i Lywodraeth Cymru os NI FYDD y rhain yn cael eu chynnwys.

Gall arwain at gyfarwyddyd gweinidogol, neu adroddiad cyhoeddedig.

For major construction (1) and outsourcing services (2) above:

- 1. Social public works clauses
- 2. Social public workforce clauses

Three steps needed:

- 1. Include in contracts
- 2. Include throughout supply chains
- 3. Put a process in place to ensure these are implemented

Notify Welsh Government if they are NOT included.

May result in ministerial direction, or a published report.

- Hyfforddiant
- Cyfleoedd i fusnesau bach a chanolig
- Rheoliad amgylcheddol

Social public workforce clauses:

- Staff yn trosglwyddo ar delerau cyflogaeth cyfartal
- Asiedydd newydd ar delerau cyflogaeth cymesur
- Rhwymedigaeth monitro

Social public works clauses:

- Prompt payment
- Employment opportunities
- Compliance with employment regulations
- Training
- Opportunities for SMEs
- Environmental management

Social public workforce clauses:

- Staff transfer on equal employment terms
- New joiners on commensurate employment terms
- Monitoring obligation

Payment

Model clauses and guidance will be published by Welsh Ministers in relation to:

- Promptness in assessing and making payments
- Ring-fencing of project funds
- Transparency of supply chain payments

in order to protect payment to supply chains

What to Do - Prompt Payment

- Include provisions in contracts requiring:
 - payment within 30 days of application to:
 - main contractors; and
 - subcontractors
 - consent to subcontracting to be withheld if the above not complied with
 - The use of a project bank account

Monitoring – Prompt Payment

- Project bank accounts:
 - Contracting Authority to sign off on payments from the account where it is an account holder; or
 - where the Contracting Authority is not an account holder require access to evidence of account transactions
- Key Performance Indicators:
 - Require evidence of payments to supply chain; and/or
 - Provide the ability for the Contracting Authority to access and audit contractor information relating to payment

Consequences – Prompt Payment

Include in the contract the consequences of failing to comply with prompt payment provisions e.g.

- the ability to terminate if the failure is not rectified within a certain period;
- withholding payment due to the Contractor while the failure remains unrectified (whilst still paying sums due to subcontractors);
- The ability to exclude a contractor from bidding for future work for a defined certain

Consequences will need to be proportionate

Project Bank Accounts

- Mandatory for Major Construction Contracts unless the contractor can satisfy the Contracting Authority that its payment processes are as good as or better than a PBA
- All subcontractors to join PBA unless exemption provisions are met or with Contracting Authority consent
- Applications for payment to include breakdowns for all PBA subcontractors

Retentions

Cash Retentions

- Ring-fenced bank accounts administered by the Contracting Authority
- All subcontractors from whom a retention is being held to sign up
- Multiple release provisions so that sums are released to subcontractors on completion of subcontract works

Retention Bond

• To be used where retention cannot be ring-fenced. Contracting Authority will be expected to pay bond premium

Employment

- Contractual obligation to adopt inclusive recruitment and employment practices
 - Employment Plan
 - Provision of data
- Optional clauses
 - Ethical Code (Code of Practice Ethical Employment in Supply Chains issued by the Welsh Government on 31 May 2017) and any similar applicable schemes
 - Disability Confident Scheme, Diversity Champions and Race, Business in the Community
 - Guide to Fair Work

Compliance

- Improvement in compliance with legal obligations in relation to employment rights
- Contractual obligation to ensure they are informed and comply with legal obligations
 - Request accurate and complete information to ensure compliance

- Contractual obligation to put in place a confidential mechanism for reporting
- Optional clauses
 - Modern Slavery, Human Rights and Offshore Labour Standards

Training

- Provision of appropriate training for workers
- Training Plan
 - Comprehensive and relevant training
- Provision of information
 - Training Plan
 - Details of qualifications obtained, apprenticeships and H&S training provided



Sub-contracting

 Promoting opportunities for small and medium-sized enterprises, micro enterprises and voluntary organisations

Environment

- Resilience to climate change
- Enhancing natural environment and biodiversity
- Minimising whole life carbon emissions
- Reducing global ecological footprint

Public Services Outsourcing and Workforce Code and Social Public Workforce Clauses

- Section 32 of the Social Partnership and Public Procurement Wales Act 2023
- Contracting Authorities must have regard to the Code and should included the Clauses in any Outsourcing Service Contract
- Contracting Authorities that are subject to the Code are set out in Schedule 1 of the Act



Public Services Outsourcing and Workforce Code and Social Public Workforce Clauses

- Code sets out principles which should be applied in relation to:
 - Outsourcing of public services to private or third sector
 - Second and subsequent generation outsourcing
 - Services are insourced
- Set or principles and clauses which protect
 - Employment terms and conditions of transferring staff
 - Pension of transferring staff
 - Terms and conditions of other staff who work alongside transferring staff in providing the services that have been outsourced
- Contract management

Public Services Outsourcing and Workforce Code and Social Public Workforce Clauses

- Trade Union consultation and recognition
- Notification requirements to Welsh Ministers
 - the Contracting Authority does not intend to include Social Public Workforce Clauses in the contract;
 - Social Public Workforce Clauses are not included in the Outsourcing Services Contract;
 - There is no process in place for ensuring that obligations in Social Public Workforce Clauses are implemented;
 - there is no process in place for ensuring that obligations in Social Public Workforce Clauses are implemented where the contract is subcontracted
